Separate sealed Bids, for furnishing all materials, labor, tools, equipment and appurtenances necessary for the construction of Groundwater Well Renovations will be received by the Owner at the Salley Town Hall located at 161 Railroad Avenue North, Salley, SC until 2:00 p.m. on June 6, 2023 and then at said place be publicly opened and read aloud.

The Project consists of the following major elements: Well No. 1, Town Hall Well, demo existing well/chemical building, well head piping and other miscellaneous items, chemical clean existing well, pump test, install well pump, drop piping, well head piping, chemical feed fiberglass building with chemical metering pumps and tanks, chemical storage fiberglass building, electrical, reinstallation of existing instrumentation/SCADA and other related items. Well No. 2, Elevated Tank/Park Well, demo existing well/chemical building, well head piping and other miscellaneous items, chemical clean existing well, pump test, install well pump, drop piping, well head piping, chemical feed fiberglass building with chemical metering pumps and tanks, chemical storage fiberglass building, electrical, reinstallation of existing instrumentation/SCADA and other related items.

Each Bid must be accompanied by a Bid Bond, prepared on the form of Bid Bond attached to the Contract Documents or a Surety Company's Standard Bid Bond, duly executed by the Bidder as principal and having as surety thereon a surety company licensed to do business in the State of South Carolina. The Bid Bond shall be in the amount of 5 percent of the Bid.

No Bid will be considered unless the Bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law.

The successful Bidder for this Contract will be required to furnish a satisfactory Performance Bond and Payment Bond each in the amount of 100 percent of the Bid.
No Bidder may withdraw his Bid within 60 days after the date of the Bid opening.

The Owner reserves the right to reject any or all Bids and to waive any informalities.

This project is being funded in whole or in part by the Community Development Block Grant (CDBG) Program. All Federal CDBG requirements will apply to this contract. Bidders on this work will be required to comply with Executive Order No. 11246 and Executive Order 11375, which prohibits discrimination in employment regarding race, creed, color, sex or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Copeland Anti-Kickback Act, the Contract Work Hours & Safety Standards Act and 40 CRF 33.240.

Bidders must also make positive efforts to use small and minority owned businesses and to offer employment, training, and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of Bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the Contract.
